All board members were provided with a copy of the May 11, 2020 Town Board Meeting minutes. Supervisor Frion made a motion to approve the minutes. Supervisor Lueck second the motion. Motion carried.

Checks 10178-10201 and 2 electronic transfers were presented. Supervisor Lueck made a motion to pay the bills and approve the financial report. Supervisor Frion second the motion. Motion carried.
